## 1 Introduction

### Equalities Act 2010

- 1.1** The Equalities Act 2010 requires the Council to have due regard to the need to eliminate unlawful discrimination, advance equality of opportunity and foster good relations. The Council also needs to demonstrate its compliance with the Equality Duty. The Council therefore needs to understand how its decisions and activities impact on different people and how they are affected by policies and practices. An Equality Impact Assessment is the method by which the Council can assess the impact of a new strategy, policy or decision.
- 1.2** The assessment focuses primarily on identifying circumstances where an adverse impact may occur; an adverse impact is defined as occurring when a strategy, policy or decision has a disproportionately negative effect on a protected group or groups. Any adverse impact may be unintentional.

**1.4** This Equalities Impact Assessment is considering the Huntingdonshire Local Plan to 2036 (submission version 2018). The Local Plan sets out planning policies and proposals to guide development in the district up to 2036. Huntingdonshire is committed to providing equality in our policy-making and service delivery and continuing to improve the quality of life for residents and promoting sustainable economic growth.

## What is the purpose of the proposal?

**1.5** The purpose of the Equalities Impact Assessment is to assess the potential impact of the policies and proposals in the Local Plan on groups with the protected characteristics listed above. Each aspect is assessed by consideration of whether the policy or proposal could have a differential impact on each group of people with a protected characteristic and seeks to identify and address any potential inequalities of outcome.

**1.6** The Local Plan sets out policies and proposals for development and growth and for protection and enhancement of the natural and built environment of the district. It contains:

- A spatial vision for Huntingdonshire up to 2036 to indicate aspirations for the nature of Huntingdonshire by this time
- A series of objectives indicating how this spatial vision may be achieved
- Policies to shape the nature and scale of development
- Site allocation proposals to deliver the district's growth targets

## 2 Protected Characteristics in Huntingdonshire

- 2.1** The following section provides brief details relating to the protected characteristics where data is available.

### Age

- 2.2** The age profile of Huntingdonshire set out below is sourced from the 2011 Census as this provides the most comprehensive data available.

- 2.3** The age structure of Huntingdonshire's population closely resembles that of Cambridgeshire as a whole and the UK although with a higher cohort of those aged 45-59. In terms of protected groups Huntingdonshire has a fractionally lower population aged under 20 but a higher proportion of those aged 65-74 although this then leveled out amongst the older population to closely align with the county and national averages.

### Gender

- 2.4** The 2011 Census identified 84,532 males and 84,976 females as usually resident in Huntingdonshire, equivalent to 49.9% males and 50.1% females. This compares to 49.9% males and 50.9% females for England and Wales as a whole.

## Disability

- 2.5 The 2011 Census relies on self-reporting of people considering themselves to have a long-term health problem or disability. Of Huntingdonshire's 169,508 residents 10,653 (6.3%) considered that their day-to-day activities were limited a lot by a long term health problem or disability and 14,650 (8.6%) considered their were limited a little. these are both significantly lower than the national average figures of 8.5% and 9.1% respectively.

## Marriage and civil partnership status

- 2.6 No data is available of numbers currently joined in marriage or civil partnerships and resident within Huntingdonshire.

## Pregnancy and maternity

- 2.7 In 2016 1,973 live births were recorded in Huntingdonshire as published by the Office for National Statistics in July 2017.

## Race

- 2.8 The 2011 Census identified 89.5% of Huntingdonshire's residents as being of White British ethnicity. Other groups included: 0.1% White Gypsy or Irish Traveller, 4.5% Other White, 2.5% Asian/ Asian British, 1% Black/ Black British and 1.5% Mixed/ multiple ethnic group. In contrast 84.5% of Cambridgeshire's population as a whole identified as White British and 80.5% of England and Wales indicating that overall the White British population is more dominant in Huntingdonshire than typical which may give rise to additional impacts of discrimination on grounds of race or ethnicity.

## Religion or belief

- 2.9 Christianity is the most widespread religion held in Huntingdonshire with 60.8% of residents stating this in the 2011 Census. The next largest group was no religion at 29.5%. 1.1% of residents identify as Muslim, and 0.4% identify as Hindu. The proportion identifying as Christian is close to the average of 59.3% for England and Wales but are significantly lower than those identifying as Muslim at 4.8% or at Hindu at 1.5% across England and Wales.

## Sexual orientation

- 2.10 No data is available to identify the sexual orientation by which residents identify.

## Gender reassignment

- 2.11 No data is available to identify residents who have undertaken or wish to undertake gender reassignment.
